DIRECTION FOR USE

Nutrient Sources: Composted poultry manure

VEGETABLE APPLICATION

Soil Mix: Mix into the soil 4 lbs. per 50 sq.ft. or one ton per acre, for small to large gardens.
Topically Applied: 30-50 lbs. per 1,000 sq. ft. or less if: 1) applications are made for short season vegetables. 2) several applications are to be made throughout the growing season.

TREES

Apply 10 cups of fertilizer for each 1-inch of trunk diameter.

SHRUBS

Topically apply or lightly scratch into the soil surface at 5 lbs. per 1,000 sq. ft.

FLOWERS

Apply 3 lbs. per 100 sq. ft. Later in the growing season, a second application can be made.

TURF APPLICATION Can be applied to any type of grass at any time of year with no risk of burn when used as directed.

Cool Season and Warm Season Grasses:

A full rate of 20 lbs. per 1,000 sq. ft. supplies 1.00 lbs. of Nitrogen, 0.80 lbs. of Phosphate and 0.60 lbs. of Potash. One 50 lb. bag covers 2,500 - 5,000 sq.ft.
